**• Health Sciences**

1. Course Change: PTHA 1431, 2431, 2435

1. Course Changes: VTHT 1105, 1109, 1125, 1140, 1245, 1260, 1301, 1349, 1413, 1441, 2201, 2205, 2209, 2217, 2223, 2260, 2321, 2331
  - a. Elmer Godeny presented in three batches. VTHT 1349 updating prerequisites for Banner purposed and to change CIP code to align with WECM. Will reflect a small change in Curriculog to delete duplicate CIP code proposals. Cyndi Klausmeyer asked about \$100 course fee listed in Curriculog and if it is an older fee included in error?
