# ITEM 2. READING OF A RESOLUTION FOR THE 2014 NATIONAL CHAMPIONSHIP CHEER AND DANCE TEAMS

Mr. Borchardt read a Resolution to congratulate the 2014 National Championship Cheer and Dance teams (a copy of the Resolution is attached and made a part of these *Minutes*). Ms. Sarah Barland, Cheer/Dance Team Coach, thanked the Board for the recognition and support.

# ITEM 3. BOARD PRESIDENT RESPONSE TO PUBLIC COMMENT FROM MARCH 25, 2014, MEETING

Mr. Borchardt read a response from the Board to the public comment from March 25, 2014:

The Board of Trustees would like to take this opportunity to thank the faculty members who spoke last month about the College's ongoing reorganization efforts. We value your insight and realize we have no greater resource than our very own faculty. We are inspired by your dedication and encourage you to continue to participate in our discussions regarding Blinn's future. There is no doubt that our instructors are a critical component of this College and have been crucial to Blinn's well-deserved reputation as one of the top community colleges in the state.

The decision to restructure the College's organizational chart has not come easily. For more than a year, Blinn administrators and board members have conducted research and heard from experts such as Dr. Belle Wheelan, president of the Southern Association of Colleges and Schools; Dr. Narcisa Polonio, executive vice president of the Association of Community College Trustees; and Dr. Joseph Silver, former vice president of the Southern Association of Colleges and Schools, regarding best practice trends in community colleges across the nation. Each of these distinguished educators encouraged Blinn's board and administration to consider changes to the organizational structure to better align the College with SACS accreditation guidelines and best practices, and to provide the greatest learning environment possible for our students. After countless hours spent studying the ways in which a new organizational structure could benefit Blinn College and its students, the board is unequivocally in support of a new structure that will help the College continue to meet our community's increasing demand for a Blinn education.

In response to your concerns, we have encouraged the administration to develop strategies for obtaining and including faculty and staff input in the reorganization process. We are confident in the College's leadership team and we believe that with faculty support of a new structure, we can create a system that maximizes our students' success in the classroom. As we move forward with this endeavor, we encourage you to be confident, hopeful participants in the reorganization process.

He informed the crowd that the Board Executive Committee will be meeting with Faculty Senate leadership to further address faculty concerns.

# • LIVESTOCK JUDGING TEAM AND AGRICULTURE CLUB AWARDS

Mr. Doug Pierce, Professor, Agriculture & Applied Technologies, reviewed the academic accomplishments and awards for the Livestock Judging Team and Agriculture Club (a copy of the Livestock Judging Results and Agriculture Club Statistics for April 2013-2014 are attached and made a part of these *Minutes*). Mr. Bryn Behnke, Professor, Agriculture & Applied Technologies, discussed the activities of the Agriculture Club over the past year. The students introduced themselves.

#### SEALY CAMPUS

Ms. Lisa Caton, Director, Sealy Campus, reviewed an overview of the Sealy Campus operations and activities (a copy of the presentation is attached and made a part of these *Minutes*). She discussed various opportunities and challenges of the campus. She also discussed a recent fundraiser for scholarships for the campus and the need for Workforce Education in Sealy.

# • SOUTHERN ASSOCIATION OF COLLEGES AND SCHOOLS COMMISSION ON COLLEGES - REAFFIRMATION UPDATE

Mr. Joe Baumann, Dean, Institutional Effectiveness and Enrollment Management, reviewed progress on Blinn's reaffirmation of accreditation. The off-site report is anticipated in June with a response due in August (a copy of the Board update on Blinn's reaffirmation of accreditation is attached and made a part of these *Minutes*).

## QUALITY ENHANCEMENT PLAN

Dr. Mary Barnes-Tilley, Professor, Social Science, discussed the importance of student success and student focus. She reviewed the progress on the Blinn College Quality Enhancement Plan (QEP) and the process utilized to arrive at "Learning Communities" as the QEP initiative for Blinn College (a copy of the Board Update on QEP Development is attached and made a part of these *Minutes*). She responded to questions from the Board.

### STUDENT LIFE

Mr. Mordecai Brownlee, Dean of Student Life, reported to the Board that at this point, only 400 beds remain in on-campus housing for fall 2014. He introduced the Student Body President for the Bryan Campus to review the organization's activities and accomplishments. A Phi Theta Kappa (PTK) representative reviewed the activities, growth and accomplishments of the group (a copy of the PTK Report is attached and made a part of these *Minutes*). Representatives from the student organization Distinguished Gentleman introduced themselves and thanked the Board and Administration for their support.

### • BUILDINGS AND GROUNDS

Mr. Richard O'Malley, Executive Director, Facilities, Planning and Construction, reviewed highlights from the written buildings and grounds report (a copy of the buildings and grounds report is attached and made a part of these *Minutes*).

### ITEM 7. PUBLIC COMMENT

Mr. Borchardt reviewed the Board's guidelines regarding public comment.

Mr. Mark Bernier, President, Faculty Senate, delivered a resolution of concern on behalf of the faculty (a copy of the written resolution is attached and made a part of these *Minutes*).

Mr. Joseph Engle, Professor, Social Science, addressed the issue of communication. He acknowledged the recent increase in communication but voiced concern about an atmosphere of fear and intimidation. He is concerned about a lack of structure in the organizational change. He feels that academic communications are non-existent, specifically saying that talking is not dialogue.

Ms. Susan Slowey, Professor, Social Science, notified the Board that several faculty members who are individual members of the American Association of University Professors intend to form a Blinn College Chapter.

Dr. Blanche Brick, Division Chair/Professor, Social Sciences, addressed the Board on the latest reorganization plan. She thanked the Board for hearing the concerns of the faculty (a copy of Dr. Brick's remarks are attached and made a part of these *Minutes*).

Dr. Mark Thomas, Professor, Humanities, introduced himself and addressed the Board regarding ethics. He discussed concerns regarding the sincerity, trust and leadership of Blinn College. He discussed events that led to the recent resignation of a Division Chair and asked for accountability for this resignation (a copy of Dr. Thomas's remarks are attached and made a part of these *Minutes*).

Ms. Twila Miller, Interim Division Chair/Professor, Math & Engineering, expressed concern regarding the leadership and ability of Dr. Greg Phillips, Dean, Math & Engineering (a copy of Ms. Miller's concerns are attached and made a part of these *Minutes*).

Mr. Connor Shields, Blinn Bryan Improvement Group, presented a survey of students regarding requests for improving the Bryan Campus (a copy of the survey and results are attached and made a part of these *Minutes*), areas included are:

- 1) Outdoor seating areas
- 2) CPC covered walkway
- 3) Improved landscaping
- 4) Library hours
- 5) Need for additional computers in the Library
- 6) Need for increase in tutors and tutor hours

Dr. Linda Jones, Instructor, Psychology, Bryan Campus, spoke to the Board regarding shared governance. She thanked the Board for the opportunity to speak and for being respectful. She expressed concern over the Deans and Assistant Deans being District-Level positions. She feels like those positions not being at the campus level will be a loss for the students and faculty.

Dr. Michelle McGehee, Professor, Natural Science, spoke in support of the reorganization and the Administration. She does not support the previous comments made and stated that others share her view.
