ITEM 4. BRAZOS COUNTY CAMPUSES UPDATE

Dr. Sylvia McMullen reviewed an overview of spring enrollment. She also previewed the progress being made on the Engineering Academy at Blinn. Blinn recently renewed our Carnegie Classification. Dr. McMullen also discussed fall graduation and early childhood Christmas party.

Dr. McMullen reviewed administrative announcements and campus events (a copy of the presentation is attached and made a part of these *Minutes*). Announcements are listed below:

UPDATES

- Winter Minimester set new enrollment records with 1,524 students, a 12 percent increase over last year. Contact hours increased 27 percent to 72,896, also a new high. This growth was fueled by our online courses, with online enrollment increasing 30.2 percent (1,225 of our 1,524 students took their minimester courses online).
- 15,601 enrolled for spring semester as of 1/12/15.
- We continue to work with Texas A&M to finalize the Memorandum of Agreement that will expand the Texas A&M Engineering Academy at Blinn to the Brenham campus. The Brenham campus program is expected to begin in fall 2015 with approximately 100 students who will form a living and learning community, living together in Brenham Park Apartments and taking their classes together as a cohort. In addition to their Blinn classes, they will take one Texas A&M course, taught by a Texas A&M professor, on the Blinn Brenham campus.
- Faculty Convocation was very successful, with 31 different breakout sessions covering topics such as use of technology in the classroom, improving the classroom environment and introducing a variety of teaching methods.

CARNEGIE CLASSIFICATION

On Jan. 7, the Carnegie Foundation for the Advancement of Teaching recertified Blinn for its Community Engagement Classification, which places us among the top 5% of colleges and universities in the United States in terms of documented public service. Congratulations to Dr. Greg Phillips and the Service Learning Program, which combines community service with classroom instruction. Our Service Learning Program organizes a wealth of projects throughout the year, including our Give Kids a Smile Program, our participation in the C.A.R.S. Program and our biodiesel donations to Brenham Independent School District.

FALL GRADUATION

Our first-ever fall graduation was a huge success. Dr. Kyle Merten, Director, Alumni Relations, and the Blinn Foundation hosted a reception beforehand for the students and their families, and approximately 100 students participated in the commencement ceremony.

ECI CHRISTMAS PARTY

Our Child Development Program hosted its annual Early Childhood Intervention (ECI) Christmas party for infants and toddlers with disabilities or developmental delays. This is our fourth consecutive year to host the ECI Christmas party and this has quickly become a treasured community event for these families and the Child Development faculty and students.

UPCOMING EVENTS

We're excited to have students on campus beginning today. We have a full slate of events planned for Welcome Week, then follow it up with Involvement Week with Student Center programs designed to inform students of the various student organizations available.

HOUSING

Mr. James Reed, Director, Housing and Residential Life, reviewed the spring housing report and discussed possible changes for the fall (a copy of the housing report is attached and made a part of these *Minutes*).

ENROLLMENT

Ms. Andrea Liner, Dean, Admissions & Records/Registrar, thanked the admissions and records staff for all their hard work to start the spring semester. She reported that in one week of having the engineering academy listed as a major on the application to Blinn, 42 students have already expressed an interest for the fall. She reviewed spring enrollment, which currently shows 3% increase in headcount and 3.6% increase in contact hours (a copy of the enrollment report is attached and made a part of these *Minutes*).
